

Cheyenne County School District #17-0003 Public Hearing on Proposed Tax Request for the 2020-2021 School Year Leyton Public Schools Board of Education September 10, 2020 Immediately Following the Budget Hearing

The Leyton Board of Education met Thursday, September 10, 2020 following the Budget Hearing in the High School Multipurpose Room. Publicized notice of the meeting was posted at Leyton High School, Leyton Elementary/JH School, at various businesses in the community and on the www.leytonwarriors.org website on August 24, 2020. Publicized notice of the meeting was printed in the Sidney Sun-Telegraph on September 2, 2020. Said postings gave date, time, and location of the meeting.

- 1. Board President Jed Benish called the hearing to order at 7:57 P.M.
 - 1.1. ROLL CALL
 - 1.1.1. The following Board of Education members were present: Galen Bartling, Jed Benish, Ryan Borges, Colleen Cruise, Kevin Henke, and Anne Rexroth. Absent: None.
 - 1.1.2. The following Administrators were present: Superintendent Chris Geary.
- 2. PROPOSED TAX REQUEST
 - 2.1. Mr. Benish read the proposed tax request. Mr. Geary announced that valuations as a whole had gone down. Therefore approximately \$0.04 was needed to increase, just to cover the difference in the valuations from the 2019-2020 school year. Mr. Benish then turned it over for public comment.
- 3. PUBLIC COMMENT
 - 3.1. Public Comments were heard from Earl Reilly, Suzy Ernest, Rol Rushman, Sam Schumacher, Dennis Peters, Lisa Carter, Rob Rushman, Russ Rushman, and David Dye. Concerns included comparison of other school districts in levy request and enrollment size; that expense decisions sometimes need to be made based on "need" vs. "want"; and that the tax request had been consistent for many years and now there has been a big increase the last two years. Questions asked included 1) What is our total enrollment? And the breakdown by site? 2) Is the increase in the levy due to teacher raises and/or the addition of staff? 3) Are SPED costs reimbursed and by how much? 4) Are bills reviewed by Board members? 5) Does the Board do advance planning or have a three year plan? and 6) What percent of the budget is teacher salaries and benefits? Most of these questions were answered by the Board with a few items to be researched. A few patrons were in support of the tax request and added that high expenditures happened in earlier years and no one complained at that time; that we can't let these buildings go into disrepair; and that even if we had not built the track, the Board would still need the same levy, as those monies were in different funds.

Cheyenne County School District #17-0003 Public Hearing on Proposed Budget for the 2020-2021 School Year Leyton Public Schools Board of Education September 10, 2020 7:00 PM

The Leyton Board of Education met Thursday, September 10, 2020 at 7:00 P.M. in the High School Multipurpose Room. Publicized notice of the meeting was posted at Leyton High School, Leyton Elementary/JH School, at various businesses in the community and on the www.leytonwarriors.org website on August 24, 2020. Publicized notice of the meeting was printed in the Sidney Sun-Telegraph on September 2, 2020. Said postings gave date, time, and location of the meeting.

- 1. Board President Jed Benish called the hearing to order at 7:00 P.M.
 - 1.1. ROLL CALL
 - 1.1.1. The following Board of Education members were present: Galen Bartling, Jed Benish, Ryan Borges, Colleen Cruise, Kevin Henke, and Anne Rexroth. Absent: None.
 - 1.1.2. The following Administrators were present: Superintendent Chris Geary.
- 2. BUDGET PROPOSAL
 - 2.1. Mr. Benish read the budget proposal and Mr. Geary provided a brief overview of the budget, including a comparison with the prior year's budget. Mr. Geary noted that the meeting notice had been posted in various locations on August 24th and in the Sidney Sun-Telegraph on September 2nd. He stated that twenty copies of the budget were available at the meeting as well as some that were emailed by request. Mr. Geary added that the published budget would need to be amended to reflect cash reserve balances in the Employees' Benefit Fund, the Activity Fund, and the Nutrition Fund; but that the overall numbers would remain the same. He further compared the General Fund expenses over the past six years and showed that the 2019-2020 expenditures had gone down from the previous year. He discussed that our District averages \$300,000 per month in expenses and that the NDE likes to see schools have at least three months in reserve. Mr. Geary stated that our District meets that threshold going into the new budget year. Mr. Benish then turned it over for Public Comment.

3. PUBLIC COMMENT

3.1. Public Comments were heard from Dani Van Anne, Dennis Peters, Rol Rushman, Russ Rushman, Rob Rushman, and Jim Ernest. Items of concern included the money that was spent on the track project; that expenses are staying the same for fewer students; and that the Depreciation Fund is down from previous years. Questions asked included: 1) What other expenses are planned for the Building Fund besides the science room remodel project? 2) What were administration costs from last year and the amount of increase? 3) What are the costs per pupil? and 4) Is there too much staff or administration? Board replied to most of the comments while a few items will need to be researched.

The Leyton Board of Education met on Monday, September 14, 2020 at 7:30 p.m. Publicized notice of the meeting was posted in the Leyton High School, Leyton JH/Elementary School, at various businesses in the community, and on the www.leytonwarriors.org website on or before September 8, 2020. Said posting gave date, time, and location of the meeting.

1 CALL TO ORDER

- 1.1 Board President Jed Benish called the regular school board meeting to order at 7:32 p.m.
- 1.2 ROLL CALL
 - 1.2.1 The following Board of Education members were present: Galen Bartling, Jed Benish, Ryan Borges, Colleen Cruise, Kevin Henke, and Anne Rexroth. Absent: None
 - 1.2.2 The following Administrators were present: Superintendent Chris Geary, HS Principal Nick Brost, and Elementary/JH Principal Dana Morgan. Absent: None.
- 1.3 COMMUNICATIONS/PLEDGE OF ALLEGIANCE
 There were no communications. The Board and all visitors stood and recited the Pledge of Allegiance.
- 2 HEARINGS AND PERSONS TO ADDRESS THE BOARD
 - 2.1 Motion by Mr. Henke, seconded by Mrs. Rexroth to recess at 7:34 p.m. to wait for a patron to arrive who wished to address the Board. ROLL CALL VOTE: VOTING YES: Benish, Borges, Cruise, Henke, Rexroth, and Bartling. VOTING NO: None. MOTION CARRIED: 6-0.
 - 2.2 Motion by Mr. Henke, seconded by Mrs. Rexroth to return to regular session at 7:37 p.m. ROLL CALL VOTE: VOTING YES: Borges, Cruise, Henke, Rexroth, Bartling, and Benish. VOTING NO: None. MOTION CARRIED: 6-0.
 - 2.3 Kevin Tretter addressed the Board as to why his children are being homeschooled this year. His decision was not based on COVID, but rather the actions of an individual. He learned this summer from a former Leyton graduate that an educator had provided alcohol and had inappropriate relations with them while they were a student. Mr. Tretter encouraged the Board to look into this matter and speak with all graduates but specifically students from 2004-2007.

4 REPORTS

4.1 STUDENT BOARD MEMBERS REPORT

STUCO President, Zac Henke, and Vice-President, Brenton Abbott, addressed the Board on student activities. Zac recapped some of the STUCO activities that were implemented last school year including open campus lunch on Fridays, weekly bulletins to students, having two dismissal bells for lunch, student involvement in the hiring of teachers, and swing dance lessons. They've had several meetings this year, elected officers, and finalized Homecoming activities. Homecoming Week will be September 21st – 25th and includes themed spirit days, a bonfire, a parade, and a dance.

- 4.2 BOARD REPORTS
 - Mrs. Rexroth presented the Budget report. The Budget Committee has met and reviewed the budget documents and recommends the proposed budget and tax request of \$0.898887.
- 4.3 STAFF MEMBERS REPORT
 Irma Rios, K-12 SPED Teacher, addressed the Board by having them participate in an activity with other patrons. Everyone was given several cards and they had to match up with someone in the same grade level; the same disability; and finally the same kind of help. Their final item was a Band-Aid. Mrs. Rios described how hard it is to teach so many individual skills to a wide variety of age groups and disabilities and that there isn't one plan for all students. She referred to herself as the one little "Band-Aid" trying to fix everything. She asked the Board to consider hiring a para for the high school and the elementary to help her with the students.

4.4 ELEMENTARY/JH PRINCIPAL'S REPORT

Mrs. Morgan attended a Return to School Committee meeting, driver safety training, HAL plan and funding webinar, two MDTs, three IEPs, and meetings for administration, SPED, ESU Title 1C and 504. She also held/hosted the kindergarten graduation, 8th grade promotion, a Leyton mentor meeting, a behavioral professional development, and weekly staff meetings. Mrs. Morgan led the curriculum map discussion at the teacher in-service, continued to review and edit the Year-at-a-Glance documents, and completed lockout/fire drills and a bus evacuation. She worked with Mrs. Rios to complete SPED indicators 11/12 with the NDE and started MTSS process at the elementary, led by Ms. Primm. She stated that formal Danielson evaluations will begin on September 22nd.

4.5 SECONDARY PRINCIPAL'S REPORT

Mr. Brost attended meetings for administration, the MTSS team, teacher mentors, an IEP, and MAC Conference ADs. He facilitated a student 504 team meeting, scheduled Fall NWEA MAP testing for September 21st – October 15th, and met with Sheyanne Meadows of NDE on the HAL program. He also completed lockout drills and a bus evacuation at the high school. Mr. Brost announced that Homecoming is scheduled for the week of September 21st-25th. He also stated that there has been successful implementation of the "Warrior Period" during the school day as time for study hall, guidance, enrichment and eligibility work.

4.6 SUPERINTENDENT'S REPORT

4.6.1 CONTRACT DAYS

Mr. Geary completed 18.5 days in August for his 2020-2021 contract, plus an additional 28 hours.

4.6.2 MEETINGS/TRAVEL

Mr. Geary had meetings with the Budget Committee to finalize the proposed budget based on certified valuations; with NSAA Student Representative, Brenton Abbott, to discuss his meeting and ideas for our school; and with Pam Brezenski, our ESU SPED Director, to review planning for the year. He also attended meetings for administration, MAC Conference Superintendents, ESU Superintendents, HAL, and the Leyton Foundation.

4.6.3 CONSTRUCTION UPDATES

Mr. Geary stated that patches have been made on the track and we are still waiting on other minor repairs.

4.6.4 ACTION ITEMS

Mr. Geary reviewed the action items including changes to policies #3028; #4040; #6007 and #6008. He also reported that the Board would like clarification from the Nebraska Accountability and Disclosure Commission regarding conflicts of interest in small school districts where, often, board members are related in various way to employees at school. The school attorney drafted a query to address this concern.

4.6.5 OTHER ITEMS

Mr. Geary congratulated our district staff for receiving the ALICAP safety award. Our trainings and their attention to detail have kept us all safe and as a result qualify our district for a significant discount on our insurance premium. He emailed the board a copy of our ALICAP inspection and said that Ken Navratil visited both sites and was pleased with what he found. Mr. Geary stated that we received a significant incentive for our use of the Distance Learning (DL) system, however, continuing availability of these funds is uncertain at this time. He added that at the Budget Hearing, he had suggested that we would need to amend the published Budget to show cash reserves in the Employee Benefit, Activity, and Lunch funds. Mr. Geary visited with Janice Eret at NDE and was told that it wasn't necessary to change it; it was fine as it was published.

Superintendent Notes; October 2020

It's already October! Wow...time flies. There is much learning happening at Leyton Schools. I enjoy my monthly walks through the halls and classrooms observing the outstanding work of our students and teachers. The school year is in full swing and things are progressing nicely.

I'm so incredibly proud of our staff and students with respect to COVID. We have continued to do our best to clean and sanitize our facilities (Thank you Mark, Bruce, and Jacob – and teachers), we are practicing social distancing when we can, and we are paying close attention to hand washing. As a result, we have not had any cases of COVID at Leyton. Thank you, also, to our parents, for ensuring that our students understand the importance of being safe and doing what we can to limit the spread of the virus.

This fall, Leyton will be participating in the SFSP (Summer Food Service Program), an extension of a grant allowed by the Department of Agriculture. This program aims to reduce the impact of COVID on our families by providing meals to all students at no charge. Students will continue to incur charges for seconds, extra milk, and additional entrées. This program began September 14 (but was retroactive to September 1) and will continue until December 21, 2020 or until funding is exhausted.

The Nebraska Department of Education will be conducting a survey regarding home internet access for students in the entire state. The goal is to better understand the needs of students as it relates to remote learning. I remain hopeful that we will NOT be required to go to remote learning in the 2020-2021 school year. However, we will be required to collect this data for the Department. Mrs. Haley, our Technology Coordinator, will be contacting each and every family to get your answers to about five questions. The information will ONLY be shared with the Nebraska Department of Education and Leyton Public Schools. Thank you for helping us help the families in our district by better understanding what we need to provide for high-quality remote instruction, should that become necessary in the future.

Leyton recently participated in another grant through Panhandle Public Health District to test for lead in the water at our elementary site in Gurley. I'm pleased to report that we collected 15 water samples in Gurley and EVERY sample was well below the acceptable limit of 15 units. Many samples were close to 1 unit, and some were so low they didn't even register.

Finally, I'd like to invite all interested parties to consider being "The Voice of the Warriors." I continue to be the announcer for football games, and will continue until a community volunteer is found – I am simply filling in on an as needed basis. I will gladly hand you the microphone! This job is for football, basketball, and track (Home contests only)! If you'd like to be the one everyone hears on the PA, give Mr. Brost a call at school, 377-2301.

Dear Leyton Families,

We are quickly approaching the end of the fall season. At Leyton we already have an outstanding number of students involved in activities and we believe that students who are involved in activities, whether it be athletics or fine arts, tend to do better in their classes. Please encourage your student(s) to be involved in our activities we offer. When students are involved in activities, they learn respect, discipline, communication, reliability, plus many other life-long skills. Activities your child can be involved in besides athletics at Leyton are Band, Choir, Fine Arts Club, FFA, Speech, One Act, Quiz Bowl and eSports. eSports is a new program this year at Leyton High School where students meet after school 2 to 3 times a week to practice gaming and compete in tournaments with other schools across Nebraska. If your child is interested in joining our eSports team, please contact Mr. Haley.

We have some important assessment dates coming up at Leyton. The Fall NWEA MAP testing window is from September 21st through October 15th. The MAP test is an adaptive test, which means each student gets a unique set of questions based on their responses. It is designed to find the students' current level of achievement in Language, Reading, Math, and Science. Students are able to take the MAP test three times a year (Fall, Winter, and Spring). Any student who is concerned with the results of their Fall MAP test can begin receiving supplementary instruction using Edgenuity immediately to help close the achievement gap. Another important assessment date on the calendar this fall is Senior ACT testing day. The date for Leyton's ACT test for seniors is October 6th. This is a make-up test due to the Covid-19 interruptions last spring.

The cooler weather of fall seems to have set in and snow will be falling soon. The elementary/JH students who wait for the bus at the high school are not allowed in the building until supervision is provided at 7:15am. Please plan accordingly.

As we continue through the school year, if misunderstandings and disagreements occur between your student and their teacher or coach it is important to follow the complaint procedure as outlined in the student handbook. As good communication helps resolve many misunderstandings and disagreements the first step is for the complainant to speak directly to the person with whom the complainant has a concern. In most cases, this means your student should discuss the situation with the teacher or coach. If the initial meeting does not resolve the conflict, the student would address the concern to the building principal and/or activities director. The complete complaint procedure policy (Board Policy #2006) can be found in the student handbook or on the Leyton website.



Discuss personal vs. private info.
