CALL TO ORDER:

President Suzy Ernest called the regular school board meeting to order at 7:00 p.m. The public was informed of the Open Meetings Act posted on the wall of the multi-purpose room. Publicized notice of the meeting was posted in the Sidney Sun-Telegraph, Leyton High School, Leyton Elementary/JH, at various businesses in the community, and on the www.leytonwarriors.org website on or before Wednesday, December 8, 2021.

Members present: Ryan Borges, Lisa Carter, Suzy Ernest, Rol Rushman, Sam Schumacher, and Dave Wiedeman. Members absent: None. Also present were Superintendent Chris Geary, Elementary/JH Principal Dana Morgan, and HS Principal Ryan Plummer. In addition, there were approximately forty-five visitors.

A thank you from KPE Inc. was read. The Pledge of Allegiance was recited.

Moved by Borges, seconded by Rushman to approve the agenda as amended with a date correction.

Public comments were heard from Bruce Ernest and Kevin Tretter.



Happy New Year! I hope you all enjoyed a wonderful Christmas. As we prepare for the New Year, I'd like to reflect on some of our past successes. Results from the Spring 2021 NSCAS Assessments has become public and our district was highlighted on the front page of the Bridgeport News Blade on December 8. We are officially #1 (It was a tie). Leyton leads the Panhandle in the percentage of students who were proficient on those benchmarks! What a great accomplishment. Interestingly, I found this quote from my December 2019 Message:

- 1) The board has set an ambitious goal of having 80% of our student attain "proficient" status on the mandated state testing. A few classes have reached that goal already, many are close, and some need significant work to reach that level.

While we still haven't reached our goal – we are making great progress on that journey! And we will continue to help our students find success.

Speaking of success, I have included our Annual Report in this month's newsletter. Have a look. I'm confident that you'll see success in almost every area. I'm proud that we accomplished what we set out to do when I was hired four years ago. One area of concern is our attendance rates. You can see that more than ¼ of our students missed more than 15 days of school last year. That makes learning more difficult for both teachers and students. We continue to investigate ways to improve our attendance.

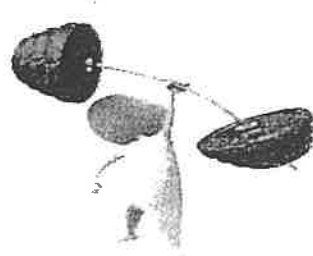
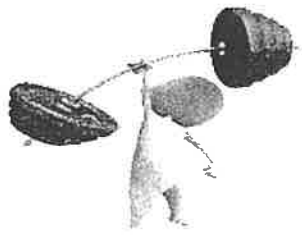


Leyton Warriors Weight Gainers through the beginning of the PLT4M app. (PLT4M program began in the summer of 2019)
